

# **Cookies policy**

1. What are cookies ?

To make this site work properly, we may place small data files called cookies on your device. A cookie is a piece of information in the form of a very small text file that is placed on an internet user's hard drive. It is generated by a web page server, which is basically the computer that operates a web site. The information the cookie contains is set by the server and it can be used by that server whenever the user visits the site. A cookie can be thought of as an internet user's identification card, which tell a web site when the user has returned.

Most browsers automatically accept cookies but you do not have to accept them. You can usually change your browser to prevent acceptance and you should still be able to enjoy most of the features on the sites. If you want to delete any cookies that are already on your computer or to stop cookies being accepted in future you should refer to your browser manufacturer's instructions by clicking "Help" in your browser menu.

# 2. For what purpose do we use cookies ?

In order to improve your browsing experience and provide certain functionalities cookies may be stored on your computer when you visit our web pages. Cookies are used by MARELLI so that :

- you can reduce the need to login and remember passwords
- settings are automatically adjusted settings in accordance with preferences
- MARELLI can provide content which is most applicable according to data provided in forms etc
- forms fields can be automatically pre-filled

Tracking cookies may also be used to identify frequently viewed pages, or browsing routes to help improve the future development of the website or to highlight, suggest or present you with related content which may be of interest based on the visited pages. The data collected are also used for statistical analysis purposes of the website. Data is stored on a third party webserver.

### 3. Third-party Cookies

If you use social sharing plug-ins or social sign-in, and use this to connect to related social sites including but not limited to sites like Twitter, Linked In, YouTube, Facebook, or Google+ from our site, then it is possible that these sites will also place cookies on your device in order to function. MARELLI has no control over these cookies and does not record or track any data linked to them.

### 4. Google Analytics

MARELLI also uses «Google Analytics» for analytical purposes. This analysis tool installs cookies that we use to quantify visits (traffic) on the website. This allows us to know how many times a specific page has been read. We use this information only to improve the content of our website or as a basis for a new campaign on a certain topic of high interest. The use of these cookies for analytical purposes is subject to your prior consent. These cookies will therefore only be installed on your device after your consent.



5. How to control cookies ?

You can control and/or delete cookies as you wish.

MARELLI uses the AXEPTIO 'Cookies Management Platform'. When the user logs into our site, a popup appears inviting the user to accept, refuse or select cookies. Please note that certain functionalities or services may not be available if cookies are deleted or cannot be accepted as we will be unable to recognize the information related to your computer.

On the other side, you can delete all cookies that are already on your computer and you can set most browsers to prevent them from being placed.

If you do not wish to provide this information please adjust your internet browser settings to security levels as appropriate so that cookies are blocked and erased from the hard drive, or you are warned before any cookies are stored.

### 6. Collecting and processing of data

When a user accesses a web page, data is recorded which may include information such as:

- your IP address
- which operating system is used
- the "url" through which you reached our website
- the name of the file/page accessed
- the date and time of access and how long they stayed

Note that cookies themselves do not contain any personal information. Browsing of our websites does not require any personally identifying information.
